knowingly represent a person in the same or a substantially
related matter in which a firm with which the lawyer formerly
was associated had previously represented a client. Thus,
under paragraph b 1representation is prohibited if in the
circumstances the lawyer cannot reasonably conclude that the
lawyer will be able to provide competent and diligent
representation.

The duty not to reveal information relating to representation of a client
lawyer has a duty to act in good faith.
